- Communication and Inclement Weather Updates: Dr. Hancock asked all present how we are receiving notifications about school delays/cancelations due to inclement weather. Various answers were given. Dr. Hancock described the many forms that this information is communicated including notifications through the MTWP website and app, FB page, twitter, and local TV stations. Many teachers also send out emails or notifications through Remind. Phone calls are only used for Early Dismissals. There is a concern that some people do not receive the notifications in a timely manner. Please ensure that your current contact information (phone numbers/emails) is up to date with the school as this can be one factor in not receiving needed communication.
- I-pads will be disturbed to all students Feb 8 and 9th. Dr. Hancock explained that students will not be working on I-Pads all day, but the technology will be utilized to enhance certain learning lessons. Amy asked what happens to the I-Pads that were donated by the PTO. Dr. Hancock reported that they are currently on the I-Pad cart, but it was still uncertain what happens to these items when all students have their own I-Pads.
